## Participants

Participants will be differentiated between EUROAVIA members and non-EUROAVIA members and subsequently between those who opt for the **Advanced** tier (accommodation in CGN, breakfast at accommodation, catering at GEN Days and entrance to the event) or the **Basic** tier (catering at GEN Days and entrance to the event).

- EUROAVIA members: 35 participants
- Non-EUROAVIA members: 15 participants

## Application rules

To apply as participant of the event, you must fill the google form available on the website <https://gendays.euroavia.eu/> or click on this [Application form](#).

### 25<sup>th</sup> of August 2025 at 12:00 UTC

The first round of applications opens.

The applications are processed in a “*first come- first served*” way.

### 30<sup>th</sup> of September 2025 at 12:00 UTC

The first round of applications ends.

### Until 2<sup>nd</sup> of October 2025 at 12:00 UTC

Confirmation emails for the applicants will be sent to each (P)AS. Once the membership is confirmed, personal confirmation emails with a reminder of the cancellation rules plus the payment information will be sent to every accepted participant in this first round.

## Payment

For EUROAVIA members:

The participation fee is 80€ (EUR eighty). It covers three (3) nights (25-28 of November 2025) of accommodation, every meal except from dinner for the days of the event (breakfast, lunch and coffee breaks in the venue), and transportation to the venue(s) of the event.

For non-EUROAVIA members:

The participation fee is 20€ (EUR twenty). It includes the entrance to the whole event and meals offered in the venue (lunch and coffee breaks).

The payment information regarding the participation fee will be provided to the participants via email, once confirmed.

Arrival and departure will be paid for by the participants and must be arranged by them. EUROAVIA will not provide accommodation outside of the event dates. However, if a participant needs to stay extra days, EUROAVIA will assist him/her in finding proper accommodation.

## Cancellation rules

In the case that a member has been confirmed by the organizing committee to participate in the Generation EUROAVIA Networking Days (GEN Days), but, for any reason, is unable to participate in the event, there is an option of cancelling the participation.

In order to do so, the member will have to send an email to [angeles.fuentes@euroavia.eu](mailto:angeles.fuentes@euroavia.eu) stating the reason for the cancellation and the participation fee will be partially/fully paid, based on the following criteria:

For EUROAVIA members:

22/10/2025 at 23:00 UTC – 29/10/2025 at 23:00 UTC	75% (60 €)
From 29/10/2025 at 23:00 UTC	100% (80 €)

For Non-EUROAVIA members:

Period of cancellation	GEN DAYS cancellation fee to be paid
Before the 10/10/2025 at 23:00 UTC	0%
10/10/2025 at 23:00 UTC – 17/10/2025 at 23:00 UTC	25% (5 €)
17/10/2025 at 23:00 UTC – 29/10/2025 at 23:00 UTC	50% (10 €)
22/10/2025 at 23:00 UTC – 29/10/2025 at 23:00 UTC	75% (15 €)
From 29/10/2025 at 23:00 UTC	100% (20 €)

If the member cancels his/her participation, the respective Local Group or WG is responsible for transferring the cancellation fee to the event organisers, under the condition that his/her place cannot be filled by someone else on the waiting list.

Participants on the waiting list that are admitted due to cancellation will have the possibility to cancel within one (1) week from receiving the acceptance email without paying a cancellation fee.

After this week, the cancellation fee will be according to the periods listed above.
